USER AGREEMENT, PRIVACY TERMS, INTELLECTUAL PROPERTY POLICY

University Counseling Jobs, LLC ("UCJ"), provides job-posting services to educational institutions to enable them to find counseling candidates while serving the job-seeker market by providing timely, convenient, and helpful organization of counseling opportunities in educational settings.

1. Use for Higher Educational Job Posters and Personal Use of Job Seekers Only.

The services provided on this website are intended for institutions in the field of higher education that seek candidates for counseling jobs in their institutions and potential applicants for those positions. All other posted positions care considered "Mis-postings." UCJ will grant a refund for one Mis-posting per posting institution and, thereafter, any Mis-postings will be removed without refund.

2. User Content and Submissions.

All submitted, posted, or displayed information, material, or content posted on our website by a user is the sole responsibility of the User and is referred to as "User Content." With regard to your User Content, you represent and warrant that you have the right to submit, post and display it, that it does not infringe the intellectual property rights of any third party, and that UCJ claims no ownership or control over User Content and takes no measures and has no obligations, other than as set forth in Section 6 of this Agreement, to protect your intellectual property. Although, you retain all patent, trademark, and copyrights to any User Content you submit, post, or display on our website and you are responsible for protecting those rights, as you deem appropriate, and in return for using our website, you grant to us a worldwide, non-exclusive, royalty-free, transferable, sub-licensable license to use, reproduce, adapt, distribute, and publish such User Content. UCJs reserves the right to refuse to accept, post, display or transmit any User Content at its sole discretion.

UCJ may review and remove any User Content that, in its sole judgment, violates our policies, applicable laws, or is abusive, disruptive, offensive, or illegal, or violates the rights of, or harms other users, third parties, or UCJ.

4. Linked Content

UCJ or some of the postings for jobs may contain links to websites over which we have no control. UCJ cannot and does not screen the sites referenced. 5. Use of Data / Privacy

With regard to job seekers, UCJ collects your email address and some other personally identifying information. With regard to job posters, UCJ collects information concerning the originator of the posting, the institutions, and the type of job posted.

We collect limited non-personally identifying information your browser makes available whenever you visit any website through the standard use of "cookies" as commonly used on the internet. This log information includes your Internet Protocol address, browser type, browser language, the date and time of your query and one or more cookies that may uniquely identify your browser. This information is aggregated, and we use the information to monitor operation and improve our services.

UCJs uses personally identifying information to improve our services to you and improve our website. At this time, UCJ does not provide your personally identifying information to other companies or advertisers of goods or services but UCJ reserves the right to do so. If you do not wish your personally identifying information to be shared with third parties, please contact us at Support@UniversityCounselingJobs.com.

We may use your data for:

- internal market research and product development/enhancement
- metrics and estimates for utilization rates. While these metrics and estimates are considered accurate, their accuracy may not be precise and is not guaranteed.
- research that we might present or publish at professional conferences, peer reviewed journals, trade publication and on our website.

Although we use encrypted passwords on our website to enhance your security and privacy, you are responsible for protecting your password and not providing it to any third party. UCJ recommends that Users change their passwords at least every three months. and UCJ has absolutely no responsibility for any damage caused to you through the actions of third parties who have obtained access to your password and User agrees to indemnify, defend, and UCJ harmless from any claims resulting from password or privacy breeches of the UCJ website.

6. Intellectual Property Claims.

UCJ respects legal rights and intellectual property rights. Generally speaking, intellectual property claims for services such as those provided by UCJ generally involve claims of copyright infringement or trademark infringement.

A. Copyright Claims:

i. Notice of Claim:

UCJ has in place a procedure that is compliant with the Digital Millennium Copyright Act ("DMCA"), 17 U.S.C. §512 et. seq., for reviewing requests to remove infringing content subject to copyright from our website if there is a bona fide claim that the posted material infringes your intellectual property rights.

Include the term, INFRNGEMENT in the subject line and include the following information as required by §17 U.S.C. §512(c)(3) in your notice:

- Reasonably sufficient details to enable us to identify the work claimed to be infringed or, if multiple
 works are claimed to be infringed, a representative list of such works (for example: title, author, any
 registration or tracking number, URL);
- Reasonably sufficient detail to enable us to precisely identify the material that you claim to be
 infringing and locate the material that is claimed to be infringing (for example a link to the page and
 a copy of the page that contains the accused material);
- Your contact information so that we can contact you (for example, your address, telephone number, email address);
- Although UCJ has User Information provided by Users, such information may sometimes change so
 please provide any information you may have regarding the current contact information for the
 allegedly infringing party including name, address, telephone number, and email address;
- Documentation, if any, of the legitimacy of the copyright or trademark claim you are presenting such as a copy of the Trademark Registration or a Copyright Registration. A statement that you have a good faith belief that the use of the material identified in (2) is not authorized by the owner of the intellectual property, its agent, or the law;
- A statement, under penalty of perjury, that the information in the notification is accurate and that you are authorized to act on behalf of the owner of the exclusive right that is alleged to be infringed.
- Your physical or electronic signature. Your complaint will not be processed unless you provide an
 electronic or a physical signature. An electronic signature should be provided with between slash
 marks // along with some identifying group of numbers or symbols to verify your identity, e.g., /John
 Smith #8375309/.

Resolution or Counter-Notice:

Upon receipt of your complaint, we may (a) contact whoever posted the content or (b) take down the accused content and also contact whoever posted the content. Either way, the posting party may file a "counter notice" to IPClaims@kennyhertzperry.com including the following as provided by 17 U.S.C. §512(g)(3)(D):

- Identification of the material that has been removed or to which access has been disabled and the location at which the material appeared before it was removed or disabled;
- Documentation, if any, of any rights you may have to the posted material and a statement, under penalty of perjury, that you have a good faith belief that the material was removed or disabled as a result of mistake or misidentification of the material in question;
- Your name, address, and telephone number;
- A statement that as the posting party -- you consent to the jurisdiction of the Federal District Court for judicial district in which your address is located or in a District in which UCJ may be found that

you will accept service of process from the person who submitted a notice in compliance with the section (c)(1)(C) of the DMCA, as generally described above;

Your physical or electronic signature.

If a posting party provides us with the information as required above, we may reinstate the posted content unless the party originally filing the complaint has informed us that they have filed an action in Federal District Court to restrain posting of the content.

B. Trademark Claims:

i. Notice of Claim:

If you (the "Complaining Party") would like to submit a trademark claim for violation of a mark on which you hold a valid, registered trademark or service mark (registered with the United States Patent and Trademark Office on the Principal Register or, for foreign marks, registered with the appropriate intellectual property organization of your country), UCJ requests that the Complaining Party substantiate such claim by providing the following information via email to providing the following information via email to Support@UniversityCounselingJobs.com . The words "Trademark Claim" should appear in the subject line of the email. The Trademark Claim must provide the following information in order for UCJ to consider it:

- A depiction of the trademark, service mark, registered trade dress, name, or other indicia
 of origin that is claimed to be infringed, including any registration numbers;
- The geographical area in which you claim that your trademark rights apply;
- The identifying information of the mark owner, including name, post office address, telephone number and email address;
- The goods and services to which you claim your trademark rights apply;
- The date the mark was first used in commerce anywhere by the owner of the mark;
- The date on which the mark was first used in interstate commerce in the United States;
- A short explanation as to the manner, extent, and factors that are likely to give rise to confusion as a result of the alleged infringer's use of the allegedly infringing mark;
- The webpages, URL's, or postings on UCJ's website that will allow UCJ to verify the use
 of the allegedly infringing use and locate it on the UCJ website;
- A good faith certification, signed under penalty of perjury, stating that:
 - The content of the website as identified above infringes the rights of the mark owner;
 - The name of the mark owner;
 - o That you are the mark owner or are authorized to represent the mark owner;
 - Any identifying contact information you may have with regard to the alleged infringer;
 - And that you know of no defense such as that the alleged infringer has permission to use the mark – that would justify the alleged infringer's use of the mark.

ii. Resolution and Counternotice:

Upon receipt of your complaint, we may (a) contact whoever posted the content or (b) temporarily take down the accused content and also contact whoever posted the content. Either way, the posting party may file a "counter notice" to support@universitycounselingjobs.com including the following:

- Any documentation that it has permission to use the marks alleged in the Notice of Claim;
- Any explanation, justification, or information justifying the use the mark by the posting party, including that,
 - o The material used is not likely to be confused with the mark of the Claimant;
 - o That the Claimant does not have the rights claimed in the Notice of Claim;
 - That the posting party has a license to use the material posted (if so, provide documentation of such license);
 - Any other reason why the use of the material that is allegedly infringing in the Notice of Claim is not infringing.

If a posting party provides us with the information as required above, we may reinstate the posted content unless the party originally filing the complaint has informed us that they have filed an action in Federal District Court to restrain posting of the content.

7. Your Rights and Waivers of Rights.
